NOVEMBER 10, 2025

The Mt. Enterprise Board of Trustees met in regular session on Monday November 10, 2025 at 6:30 PM in the Board Room, Mt. Enterprise Texas with the President, Regina Risinger chairing the meeting and Secretary John Walthall in attendance. Other members attending to form a quorum were: Blake Webb, Don Rogers and Travis Owens, Paul Reeves, and Hollie Henderson.

A quorum was established and the meeting was called to order at 6:30 PM.
