

Dress and Grooming (All Grade Levels) The district's dress code teaches grooming and hygiene, prevents disruption, and minimizes safety hazards. Students and parents may determine a student's personal dress and grooming standards, provided that they comply with the following:

#### BOYS DRESS CODE:

1. Caps and/or hats shall not be worn inside the academic buildings.
2. Tank tops or muscle shirts are prohibited. Shirts must cover the entire shoulder area. All shirts must be sufficient length to keep the midriff covered.
3. Pajamas and blankets are not allowed. Dress appropriately and for weather conditions.
4. Clothing shall not advertise any alcoholic beverages, controlled substances or tobacco.
5. Garments must not be offensive to any race or religion, or any pictures or words that could cause comment or be a source of disruption in the classroom or on campus.
6. Jewelry worn in association with body/facial (eyebrow, cheek, mouth, nose, etc.) piercings is permitted unless it is deemed a distraction by a campus administrator.
7. No holes showing skin (above the end of the fingertips with arms fully extended at your side) in pants.
8. Shorts should be a modest length. No blue jean cut off shorts are allowed.
9. Pants must be worn at the waistline. Baggy pants must be worn with a functional belt. The principal has the authority to use any method within reason to keep the pants in their proper place (tying belt loops together, tying pants up with string, etc.)

#### GIRLS DRESS CODE:

1. Caps and/or hats shall not be worn inside the academic buildings.
2. Tank tops or muscle shirts are prohibited. Shirts must cover the entire shoulder area. All shirts must be sufficient length to keep the midriff covered.
3. Pajamas and blankets are not allowed. Dress appropriately and for weather conditions.
4. Clothing shall not advertise any alcoholic beverages, controlled substances or tobacco.

5. Garments must not be offensive to any race or religion, or any pictures or words that could cause comment or be a source of disruption in the classroom or on campus.
6. Jewelry worn in association with body/facial (eyebrow, cheek, mouth, nose etc.) piercings is permitted unless it is deemed a distraction by a campus administrator.
7. No holes showing skin (above the end of the fingertips with arms fully extended at your side) in pants.
8. All skirts cannot be above the end of the fingertips with arms fully extended at your side in a standing position. position. Shorts should be modest length. No blue jean cut off shorts are allowed.
9. Pants must be worn at the waistline. Baggy pants must be worn with a functional belt. The principal has the authority to use any method within reason to keep the pants in their proper place (tying belt loops together, tying pants up with string, etc.)
10. All form-fitting clothes must be covered by a garment of dress that would meet the dress code on its own accord.

\*No one will be permitted to wear any apparel that is contrary to good taste as determined by the administration. If the principal determines that a student's grooming or clothing violates the school's dress code, the student will be given an opportunity to correct the problem at school. If not corrected, the student may be assigned to in-school suspension for the remainder of the day, until the problem is corrected, or until a parent or designee brings an acceptable change of clothing to the school. Repeated offenses may result in more serious disciplinary action in accordance with the Student Code of Conduct.
